The Municipal Code of Ordinances of City of Burt, Iowa, shall and is hereby amended to add thereto Chapter 110, Electric Utility, which shall read as follows:

110.05 RATES FOR SERVICE. Electric service shall be furnished at the following monthly rates within the City: *(Code of Iowa, Sec. 384.84)*

V Power Cost Adjustment-PCA

These rates are based upon a Cost of Purchase Power Index of \$0.0296 per kWh, and shall be increased or decreased periodically by a Power Cost Adjustment. The PCA shall be equal to the amount by which the average actual cost of wholesale electric energy per kWh to the City in the period since the last preceding adjustment is greater or less than the Index Cost.

92.02 Future Rates. On July 1, 2023, all electric rates shall be increased by 1.5% over the rates established in subsection 1 of this section, which rates shall be in effect until June 30, 2024. On each July 1 thereafter, until and including July 1, 2028, all electric rates shall be increased by 1.5% over the rates in effect during the preceding year.

AN ORDINANCE AMENDING THE CITY OF BURT MUNICIPAL CODE, BY AMENDING CHAPTER 92, WATER RATES

BE IT ENACTED BY THE CITY OF BURT COUNCIL OF BURT, IOWA:

The Municipal Code of Ordinances of City of Burt, Iowa, shall and is hereby amended to add thereto Chapter 92, Water Rates, which shall read as follows:

92.02 RATES FOR SERVICE. Water service shall be furnished at the following monthly rates within the City:

(Code of Iowa, Sec. 384.84)

1. Effective July 1, 2023, until July 1, 2024.
 - A. \$37.00 flat fee (minimum bill).
 - B. \$9.00 per 1,000 gallons of water and water service attributable to the customer for the property served per month
2. Effective July 1, 2023, until July 1, 2024.
 - A. \$40.00, unmetered customers (minimum bill).
 - B. All An amount established by the Superintendent based on estimated consumption, whichever is greater.

customer for the property served per month

ORDINANCE NO.231

AN ORDINANCE AMENDING THE CITY OF BURT MUNICIPAL CODE, BY AMENDING CHAPTER 106, GARBAGE RATES

BE IT ENACTED BY THE CITY OF BURT COUNCIL OF BURT, IOWA: The Municipal Code of Ordinances of City of Burt, Iowa, shall and is hereby amended to add thereto Chapter 106, Garbage Rates, which shall read as follows:

106.02 RATES FOR SERVICE. Garbage service shall be furnished at the following monthly rates within the City:

(Code of Iowa, Sec. 384.84)

- 1. Effective Premises without Dumpsters
a. \$20.30 per month for recycling and solid waste collection consisting of not more than one approved bag per week.
b. A \$2.00 single-use sticker must be attached to additional bag over the one bag per week limit.
2. Dumpsters
a. \$50.00 per load from privately owned 1 1/2 yard dumpsters
b. \$50.00 per load from privately owned 2 yard dumpsters
c. \$35.00 per load from city-owned 1 1/2 yard dumpsters
d. \$35.00 per load from privately owned commercial dumpsters.

106.02 RATES FOR SERVICE. Garbage service shall be furnished at the following monthly rates within the City. Sales tax shall be in addition to the amounts shown, in accordance with State law. (Code of Iowa, Sec. 384.84)
